Dear Sirs and Madams,

We, the Living Men and Women of Nevada, and I, Mark John Seilstad as Coordinator of The Nevada Assembly, extend cordial, amicable, peaceable and honorable greetings to you this day of April , Two-Thousand and Twenty-Three.

We wish to provide you with Lawful Due Notice and Testimony, under solemn Attestation and Witness of The Public Law of <u>The</u> United States of America, and Establish the same upon the Public Record that the following are absolutely true and correct to the best of our knowledge and belief:

- 1. that We are Peaceful, Non-Belligerent, Non-Combatant, Third-Party Civilians, American State Nationals or American State Citizens, Impost, Duty and Tax Prepaid Priority Creditors, Inheritors of and Living and Present Heirs to the **Trust Indenture** established by "The Unanimous Declaration of Independence, 1776", Members of the "Political Community" known as "The People," and Actual Beings-In-Possession and Naked Owners who are owed **amity, protection of our lives and properties, good-faith service, immunity, and aid from all Employees, Officers, Agents, and subcontractors of the British Territorial United States and the Municipal "UNITED STATES", military and civil,**
- 2. that We are not now, nor have We ever been British Territorial "U.S. Citizens" or Roman Municipal "citizens of the U.S." or any other variety of Federal United States "person, officer, employee or elected official" engaged in any "Federally-Connected Trade or Business," nor have any of our lawful Trade Names/"NAMES" or Vessels/"VESSELS" ever engaged in or been connected to such activity at any point since on or before 1860,

- 3. that We Attest and Declare that <u>any and all</u> records or "Master File(s)" purporting to show that either We or any of our Lawfully Re-Conveyed Vessels/"VESSELS" are engaged in or connected to such "Federally-connected/Privileged activity," or are functioning as Federal Persons, Officers, Employees, or Elected Officials, are incorrect or falsified.
- 4. that if any Territorial United States or Municipal "UNITED STATES" Agency, Employee, or Subcontractor wishes to Exercise Lawful *Right of Distraint or Levy* against ourselves or our property, they must bring forth firsthand proof of such Federally-connected activity or Federal status, attested to under penalties of perjury, in the Form of an Affidavit under full personal and commercial liability,
- 5. that We stringently protest, strongly object, and do not consent to any implications that We or our Vessels/"VESSELS" have ever been connected to or engaged in such activity, or attempts to "deem" or "mistake" me to be an "Officer or Citizen" of a foreign polity ("United States" or "United States of America"),
- 6. that We have **Declared and Claimed**, on and for the Public Record, our *True and Correct Birthright Political Status*, which can be found at the Land Recording Office of the Federation of States, https://everify.americanstatenationals.us by entering our full name or be found at https://search.americaunincorporated.org/public-records or presented upon request of any of us individually, when prompted,
- 7. that We have claimed Life pursuant to the 1666 C'est Que Vie Act, and that no further presumptions may be made that We are "dead, lost at sea or otherwise missing,"
- 8. that any attempts to "probate" our properties, lawful estates, or arrests/alters our course due to presumptions that We are merely "co-trustees of the Public Charitable Trust" or "debtors in-possession" shall be evidence of Fraud, Inland Piracy, Kidnapping, Conspiracy Against Rights, and Theft Under Color of Law and Taking Without Due Process,
- 9. that any attempts to "Address" us by either Agents/Agencies functioning under the oversight of the "U.S. Trustees" or the Bankruptcy/Probate "Courts" known as "U.S. District Courts" or their subsidiary Courts shall be evidence of attempted "Personation," Fraud, and extra-judicial malpractice and malfeasance,
- 10. that those functioning as our Trustees (employees) attempting to "Act" unlawfully "in our Names" are guilty by their actions of functioning as "Executors de son Tort" and are liable both individually criminally and civilly, with no explicit or implied immunity, and subject to affixed "Notice of Intent-Fee Schedule," Nevada Assembly Recording # Nv03-2022-LLLY5-VY21U found at: https://search.americaunincorporated.org/public-records and typing in the above Recording Number,
- 11. that We claim our "Mutual Offset Credit Exchange Exemptions" pursuant to HJR 192 for any purported debts against the ALL CAPS "FEDERAL PERSON(S)" such as "CRAIG PHILIP SCHMIDT, ET ALIA" that may be mistakenly attached to our, living men and women.

In order to ensure our <u>lives and properties are protected</u>, please correct all records/databases (public, private, commercial, domestic, interstate, or otherwise) that are associated, affiliated, administered, or maintained under your authority pertaining to our living men and women comprising The Nevada Assembly and their Estates regarding the matters attested to herein. In order to ensure the swift and certain correction of records, each man and woman of The Nevada Assembly will send in such individual notice to you requesting their individual records be corrected by providing their individual recorded and published proof of their claimed political status of American State National/Citizen.
